Location

Accommodation

Built in 1929 and designed by architect Sidney Perks, the Exchange offers varied accommodation. Most of the **Offices** have high ceilings and character/period features such as the original wood and woodblock floor surfaces and a number are being redecorated. Varying sizes are available on the ground to fourth floors, totalling approximately 80,000 sq ft.

In addition, there are large basement **Storage** areas, **Car Parking** spaces (the building is outside the Congestion Charging Zone), and street level units with potential **Retail** use (stpp).
